

COVID-19, snake venom and Metadichol (NANO SOMA)

[Dr. Bryan Ardis](#) has, in my opinion, brought forth unequivocal evidence that what we know as COVID-19 is actually poisoning using snake venom, most likely administered by the contamination of global water supplies, augmented by the so-called “drug”, Remdesivir, which appears to be the same venom, delivered in hospitals and possibly elsewhere, apparently to kill people. Further, the banned treatments Hydroxychloroquine and Ivermectin are totally effective in treating this condition. In response to Dr. Ardis’ revelations about the possibility of snake venom peptide delivery via water systems, there has been almost derision from certain influencers who claim that snake venom wouldn’t be stable in municipal water systems. In effect, they are claiming that tap water is anti-venom.

Nanocarriers can stabilize snake venom peptides for delivery via water. The National Library of Medicine has published a study that reveals the existence of “nanocarriers”, which can stabilize snake venom peptides in order to achieve delivery via water systems.

Entitled, “[Nanoparticles Functionalized with Venom-Derived Peptides and Toxins for Pharmaceutical Applications](#)”, the study abstract explains the mechanism by which snake venom peptides (including the 19 dangerous spike proteins) are stabilized in water and other solutions. Snake venoms have been very thoroughly analysed over the last 40 years or so and are the source of [a range of pharmaceuticals](#), so their properties and the infrastructure and tools to work with them are well established.

This is profound information and, if you watch these interviews, you will see these are divinely guided revelations.

The spike proteins being introduced into people's bodies are found in cobra venom and that of other venomous snakes. Snake bites lead to increased D-Dimer, which leads to blood clots, as observed in COVID-19 cases and those "vaccinated" for it, and NANO SOMA in many testimonials acts as a blood thinner and reduces D-Dimer levels.

Also, many people say NANO SOMA helps them sleep. That is because they are producing Melatonin. Melatonin is a powerful inhibitor of the spike protein from Cobra venom.
